Speaker Profiles

DAREN TANG has been the Chief Executive of the Intellectual Property Office of Singapore (IPOS) since November 15, 2015. Under his leadership, IPOS has evolved into an innovation agency that drives Singapore's future growth. Mr Tang holds key positions in several international and national IP and innovation-related committees. He is the Chairperson of the World Intellectual Property Organization's Standing Committee on Copyright and Related Rights. He also sits on the Research, Innovation and Enterprise Strategy Committee under the Prime Minister's Office.



ONG KENG YONG is Executive Deputy Chairman of the S. Rajaratnam School of International Studies at the Nanyang Technological University in Singapore since November 2014. Concurrently, he is Ambassadorat-Large at the Singapore Ministry of Foreign Affairs, non-resident High Commissioner to Pakistan and non-resident Ambassador to Iran. Mr Ong also serves as Chairman of the Singapore International Foundation (SIF). Mr Ong was High Commissioner of Singapore to Malaysia from July 2011 to October 2014. He served as Secretary-General of ASEAN (Association of Southeast Asian Nations), based in Jakarta, Indonesia from January 2003 to January 2008. He was Singapore's High



Commissioner to India and concurrently Ambassador to Nepal from 1996 to 1998. From September 1998 to December 2002, he was Press Secretary to the then Prime Minister of Singapore, Mr Goh Chok Tong. From 2008 to 2011, he served as Director of the Institute of Policy Studies (IPS) in the Lee Kuan Yew School of Public Policy at the National University of Singapore.





ABDUL AZIZ BIN ISMAIL is currently the IP Advisor to TEAQ IP International Sdn Bhd. Before retiring from government service in 2016, he was the Deputy Director General (Industrial Property) of the Malaysian Intellectual Property Office (MyIPO) where he led the important SPHI **MyIPO** project which modernised MyIPO's computerised IP administration system. A graduate from MARA University of Technology Malaysia (UiTM), Abdul Aziz started his career as an Enforcement Officer. After 12 years as Senior Director of the Trade Marks Division of MyIPO, Abdul Aziz became its Deputy Director General (Industrial Property). His past achievements include



negotiating the IP Chapter in bilateral or multilateral agreements between Malaysia and other countries, and serving as chairman of the ASEAN Trademark Task Force, in governmental committees (eg, Malaysian IP Court) and the ASEAN Working Group Committee in IP Cooperation (AWGIPC). He also represented Malaysia at many high level national and international caucuses relating to intellectual property including WIPO, WTO, USPTO, EUIPO, EPO, JPO, UKIPO, IP Australia.

DAVID LLEWELYN is Deputy Dean & Professor of Law (Practice) at Singapore Management University. He is also Professor of Intellectual Property Law at King's College London. David practised as a solicitor in London for 25 years and most recently was a partner and head of the intellectual property group in the London office of international law firm White & Case. After working for nearly two years as a research fellow at the Max Planck Institute for Intellectual Property Law in Munich, since 1982 he has combined legal practice with teaching, both in London and other places such as Hong Kong (where he is Honorary Professor at Hong Kong University) and Shanghai. David has spoken at international



conferences all around the world and has written extensively on intellectual property law issues. He is joint author of Cornish, Llewelyn & Aplin Intellectual Property: Patents, Copyright, Trade Marks & Allied Rights (7th ed., 2010) and has worked with others in 8 New Square on the 13th (in 2001), 14th (in 2005) and 15th (in 2011) editions of Kerly's Law of Trade Marks & Trade Names. He has also written a business book Invisible Gold in Asia: Creating Wealth through Intellectual Property (2010).





KEN CHIA is a member of Baker & McKenzie's Asia Pacific IT & Communications and Global Privacy steering committees. He is regularly ranked as a leading ITC and competition lawyer by top legal directories, including Chambers, Asia Pacific Legal 500, PLC Which Lawyer? and Asialaw. Ken is a fellow of the Chartered Institute of Arbitrators and the Singapore Institute of Arbitrators. He is also an accredited mediator with the Alternative Dispute Resolution Group in the United Kingdom. Ken has more than 20 years of practicing in the areas of IT, telecommunications, intellectual property, trade and commerce, and competition law matters. He routinely assists clients, mostly



governments and multinational corporations, in large-scale procurement, outsourcing and regional transactions, and provides sound advice on privacy and e-commerce matters.

LOCKNIE HSU is a full Professor and former Associate Dean at the School of Law, Singapore Management University (SMU). She was called to the Singapore Bar, and practised with a Singapore law firm, working on commercial contracts, general litigation and intellectual property matters. She went on to receive a LL.M. degree at Harvard University. Locknie specializes in international trade and investment law, and international dispute settlement mechanisms. Locknie also researches ASEAN economic integration issues. In 2019, Locknie launched a new course in 2019, Law & Digital Commerce, to better prepare students for the digital economy as the intersections between



technology, law and cross-border trade grow. She has published widely on trade and investment law, treaty dispute settlement mechanisms, arbitration law and sovereign wealth funds in international journals, and has spoken at numerous international seminars and conferences. She has developed both a strong local and international professional standing and profile through her cumulative work in private legal practice, government and academia.





BARBARA BERDOU started her IP career in 1994 with a boutique South African IP law firm. This was followed by a decade of practice in what was then the largest commercial law firm in South Africa. Barbara resigned her partnership in 2005 to "get a life" but founded Berdou Attorneys a few months later when she realised that life outside of IP was no life. Barbara became interested in indigenous rights as a result of her involvement with INTA (International Trade Mark Association), and currently chairs INTA's Indigenous Rights Committee which is part of INTA's Advocacy Group. This interest led her to complete the WIPO advanced course on Intellectual Property, Traditional Knowledge and



Traditional Cultural Expressions in 2016. Barbara also currently co-chairs INTA's Africa Global Advisory Council

DEBBIE DAVID is the Deputy Chief Executive Officer and Department Head of Patents at Advanz Fidelis Sdn Bhd. Having graduated with a Degree in Computing, Debbie chanced upon the realm of intellectual property, where she has been ever since. She has worked across the major types of intellectual property, prior to settling in to her present strategy and development role. She is a Registered Patent, Industrial Designs, Trademark and Geographical Indications Agent of Malaysia. She is an Hon. Secretary of the International Association for the Protection of Intellectual Property (AIPPI Malaysia Group), Committee Member of Membership Committee of the International Association for



the Protection of Intellectual Property (AIPPI) and Subcommittee Chair of the Regional IR Analyses, Indigenous Rights Committee of the International Trademark Association (INTA).





MILA FEDERIS is the co-founder and managing partner of Federis & Associates Law Office, a boutique law firm. Ms. Federis works with clients from a wide range of industries, including pharmaceuticals, consumer goods, hotel, leisure, electronics, automotive, telecommunications and IT. Her extensive experience in an IP-focused practice involves copyright, trademark and design prosecution, enforcement, licensing, advertising and privacy issues. She manages a range of trademark work, from clearance to prosecution and maintenance. Ms. Federis is involved in committee work for professional organizations. She organized a roundtable conference for



the International Trademark Association (INTA), moderated an INTA conference panel discussion and represented INTA at an Asia-Pacific Economic Cooperation IP Rights Experts' Group consultation. She is a regular contributor to the Philippines section in INTA publications In addition to her professional activities, Ms. Federis devotes time for pro-bono cases. She acted as defense counsel for students accused in anti-subversion cases and was defense counsel for seven women accused in a criminal case for malicious mischief. Ms. Federis is also a passionate proponent for the firm's annual gift to the Office of Legal Affairs at the University of the Philippines College of Law and is a regular contributor to the funding of non-government organizations involved in the rescue and rehabilitation of street children.

AARON THNG is an Associate Director of Amica Law LLC. He graduated with an LL.B (Hons) from the National University of Singapore and was called to the Singapore Bar in 2013. He is also a domain name panellist of the Regional Arbitration Centre of Kuala Lumpur and a principal mediator of the Singapore Mediation Centre. He is an active participant



of various local and foreign professional and business organisations, contributes regularly to professional publications and is frequently invited to speak on topics in the IP field both locally and regionally at conferences, seminars, workshops and expert panels.

EMIRSYAH DINAR is a senior associate at AFFA Intellectual Property Rights Indonesia & Timor Leste and is a registered Intellectual Property Consultant in Indonesia.
